#### PRIVATE PRACTICE PROFILES

## **Current practice in Shubenacadie, NS:**

Assessment and treatment services for adults, children, teens and families. Clients are referred by community members, Family Physicians and Lawyers. First Nations clients are supported by Non-Insured Health Benefits and by First Nations and Inuit Health, Health Canada services for Residential School Survivors and families. Services for Veterans and RCMP members are billed to Blue Cross.

Assessment services for adults include evaluation for treatment planning, diagnosis of trauma, personality, behaviour and mental health status, with focus on impact for relationships, parenting, work life and personal wellbeing. Assessment work with children and teens is focused on investigations of social/emotional development, self-esteem, personality development and family integration.

Treatment services for adults, children, teens and families center on client strengths and acknowledgement of growth toward self-efficacy and independence. Treatment modalities are chosen from evidence-based best practices and matched to client profile and goals. Therapy in both individual and group format is offered for anxiety and mood disorders, family and relationship issues, stress, lifestyle, behavioural and performance difficulties. The treatment interventions most often used are Cognitive Behavioural Therapy and techniques from Interpersonal and Supportive Therapies.

#### Practice in Peterborough, Ontario (1992-2005)

From 1992 to 2005, my practice was divided between office-based client services and contract services to a variety of agencies and institutions. The office-based services were essentially the same as those of my current practice, with the addition of expanded service access for First Nations clients, assessment of clients of Worker's Compensation agencies, Disability Assessment Centers, university and collage special needs students, and a range of services for clients referred by insurance companies.

Contract services included the following:

- teaching in the Psychology Department of Trent University
- short-term contracts to provide assessment and therapy services in Psychology Departments at Oshawa General Hospital(children's services) and Peterborough Civic Hospital (adult services)
- develop and provide Employee Assistance Programs for St.Joseph's Hospital, Peterborough and for the local employees of a large international mining company

- contracts to deliver assessment and treatment services to Corrections Services Canada for adult offenders on community release plans and incarcerated at Warkworth Penitentiary. Assessments featured diagnosis of mental health issues, community readiness and potential risk. Treatment had a rehabilitation focus.
- contracts to provide consultation to management, clinical teams and youth workers at several locations of Kinark Child and Family Services, as well as delivery of assessment and therapy services for complex clients served by this agency. Included such roles as a Senior Clinician Intake Triage Team, Trainer for the staff's annual ethics course, consulting Psychologist for a secure residential treatment facility. Continuous contracts between 1990 and 2005.
- short-term contracts to provide assessment and treatment services to clients referred by provincial parole services (primarily for adult sex offenders)
- term contracts to provide assessment and individual treatment for referred children and youth and consultation services to regional Children's Aid Societies. Referred clients included neglected and abused children in foster care and children considered to be at risk. Parent and family assessments were, at times, included in the services requested.
- term contracts for provision of consultation to the Woman's Eating Disorder Clinic of Peterborough Civic Hospital. Services included intake screening, treatment planning and staff consultation and support.
